Dear Sirs,

We refer to your letter dated 27th January 1992.

We are of the view that the membership of Kai Uwe Pel can be terminated on the basis of Articles 10 (a), (b) and (c), namely:-

"10. The membership of a member shall be terminated upon it being so decided by a majority of not less than two-third of the members of the Committee at a meeting of the Committee in any of the following cases, namely:-

- (a) If he violates the Articles of Association of the Association or if he fails to pay his annual subscription to the Association for more than a year.
- (b) If he misbehaves himself so as to damage the fame and benefit of the Association.
- (c) If he makes oral or written statement in public to libel against the Association."
